USAID's SAFEMed Project implemented by Management Sciences for Health (MSH) in Ukraine is looking for young professionals just like you to *join our team for 12 months as junior consultants*. SAFEMed set up a Young Professionals Program called "Jumpstart" for the new graduates/young professionals to try themselves out as civil servants and/or development professional who will work under direct guidance and oversight of more experienced development professionals, or government agencies.

## "Jumpstart" will offer you an opportunity to:

- Jumpstart career at the international organization;
- Be exposed to the international experts in pharmaceutical management and public health;
- Be part of the history in making;
- See healthcare reforms in action;
- Shape the future of their own country.

Under "Jumpstart", SAFEMed will select young professionals, recent graduated from select universities to work as long-term interns in the following areas:

- Public health, public policy and management, and public procurement
- Pharmaceutical management
- Economics

## The process is simple.

- 1. Submit your CV or brief letter in English by February 16, 2020 at ua-safemed@msh.org
- 2. Get invited for an interview to meet our staff
- 3. If selected, join our team as junior consultants by the end of March 2020 or earlier.

Each young professionals selected will work at the SAFEMed office or at the Ministry of Health *for 12 months with a monthly pay of 16,000 UAH* (gross). At the end or during the program, junior consultants will also have an opportunity to transfer to the MOH or other civil healthcare authorities by passing exams and fulfilling vacant positions.

**About SAFEMed:** With funding from United States Agency for International Development SAFEMed (September 2017 – August 2022) applies health system strengthening best practices to create evidence-based interventions and strengthen Ukraine's pharmaceutical system in line with the MOH health reform.
