I. STATEMENT OF WORK

A. Required Items

Description/Technical Specifications

Global Communities is looking for a reliable Supplier to supply a trade pavilion and booths for Arbuzynska CC (Mykolaivska oblast) in accordance with the requirements set out in Annex A.

Quantity: modular trade pavilion - 1 piece; wooden trade booths - 4 pieces.

II. INSTRUCTIONS TO THE PROSPECTIVE SUPPLIER

A. Form of Quotation

Your quotation must specify and include confirmation of the following:

- 1. Annex A Requirements Table Completed and submitted.
- 2. Annex B Bidder Evidence of Responsibility Completed, signed and submitted.
- 3. Adherence to Technical Specifications. Bidder shall confirm on <u>Annex A</u> whether the items meet or exceed the required requirements of the technical specification, design and estimate documentation.
- 4. Ocean Shipment Bidder must specify on <u>Annex A</u> whether U.S. flag carrier is available for shipment of items. Bidder must quote the cost of a U.S. flag carrier where such service is available. USAID will not grant a Determination of Non-Availability where U.S. flag service is available.
- 5. Country of Manufacture Bidder must specify on Annex A the country of manufacture of the items.
- 6. Source of Items Bidder must specify on Annex A the country where the items are located and available for purchase.



- 7. Nationality of Bidder. Bidder must specify on <u>Annex A</u> that it is legally registered for business in a Geographic Code 110 or 937 Country, and provide a valid business, employer or tax identification document that demonstrates this.
- 8. After-Sales Service Bidder must specify on <u>Annex A</u> the name and location of an authorized after-sales service center for the items.
- 9. Quotation Validity Bidder must specify on Annex A quotation validity of no less than 180 calendar days.
- 10. Bidder Eligibility must be eligible to participate per E.7 of this RFQ
- 11. Price for each item. Price for the goods must be stated UAH currency <u>Note: Price should be without VAT.</u>

 The Buyer is exempt from taxes within the customs territory of Ukraine.
- 12. Delivery Schedule Bidder must specify when items will be delivered at named destination.
- 13. Warranty Terms Bidder must specify the warranty period for each item.

B. Evaluation Factors

Quotations will be evaluated as described below. Global Communities shall first evaluate mandatory factors on Acceptable/Not Acceptable basis to determine whether they meet the stated requirements. The quotation that passes all mandatory requirements and earns the most points out of 100 will be determined to offer the best value to Global Communities and USAID. In conducting its evaluation, Global Communities may seek information from any source it deems appropriate to obtain or validate information regarding the Supplier's quotation.

C. Questions on this RFQ

Questions should be sent by **no later than 12:00 local Kyiv time, January 12, 2021** via email to: dobreprocurement@globalcommunities.org. Any information given to one Bidder concerning this RFQ will be furnished to all Bidders as an amendment to this RFQ.

S = (60 x LP)/ OP, where "S" is the score, "LP" is the lowest price, and "OP" is the offered price under consideration. ** The proposed payment terms will be evaluated according to the following methodology, where the maximum number of points (10) is received by the proposal submitted by bidder who agrees to 100% post-payment within 30 calendar days after delivery; 5 points – prepayment up to 25%; 0 points - prepayment more than 25%.



D. Contract Award

The Bidders should submit its best offer initially as Global Communities intends to evaluate quotations using the evaluation factors listed above and make an award without discussions. However, Global Communities reserves the right to conduct discussions if, following the evaluation, Global Communities deems it necessary.

E. Terms and Conditions

- 1. Financing of awards resulting from this RFQ will be through the U.S. Agency for International Development (USAID). Awards financed by USAID may be subject to prior approval requirements.
- 2. The authorized geographic code for this procurement is Code 110 and 937 which means the U.S., the independent states of former Soviet Union, and developing countries. The list of USAID-approved developing countries can be obtained from this internet address:

- 3. Items must be available for purchase in Code 110 country at time of contract signing. Bidder may not import the items from a country outside of the authorized geographic code prior to contract signing for the purposes of circumventing this requirement.
- 4. The Bidder must be registered for business and operating in a Code 110 and 937 country.
- 5. Global Communities is a tax exempt organization; therefore, no taxes should be assessed on the price of the items. Tax exemption certificate is available upon request.
- 6. Global Communities reserves the right to accept or reject any quotation, and to cancel the bidding process and reject all quotations, at any time prior to award, without thereby incurring any liability to Bidders or any obligation to inform Bidders of the grounds for Global Communities action.
- 7. (a) Global Communities complies with U.S. Sanctions and Embargo laws and Regulations including Executive Order 13224 on Terrorist Financing, which effectively prohibit transactions with persons or entities that commit, threaten to commit or support terrorism. Any person or entity that participates in this bidding process, either as a prime or sub to the prime, must certify as part of the bid that he or it is not on the U.S. Department of Treasury Office of Foreign Assets Control (OFAC) Specially Designated Nationals (SDN) List and is eligible to participate. Global Communities shall disqualify any bid received from a person or entity that is found to be on the List or otherwise ineligible.
 - (b) Firms or individuals that have an active exclusion on the System for Award Management (www.sam.gov) shall not be eligible for financing and shall not be used to provide any commodities or services contemplated by this RFQ.
- 8. Any changes to this RFQ shall be through amendment. Copies of amendments will be furnished to all prospective Bidders.



The material of the trade slaughterhouse is pine. Wood must be treated with a special fire and antifungal agent.

The framework is made of a bar of assembly 100 * 50 mm.

Floor from a rabbeted board of 35 mm, logs of 100 * 50 mm, a bar.

The roof is metal tile. The color is dark brown.

The case - a covering board of 100 * 20 mm, light color with allocation of texture of wood.

Entrance doors on a back wall of a slaughterhouse, fastening under the padlock.

All wooden parts are covered with two layers of ecological water varnish.
