#### Full description of needs / Terms of reference / Specifications

#### 1. General information

To support the Ministry of Health of Ukraine (MOH) efforts, the United States Agency for International Development (USAID) awarded an 8-year contract for Safe, Affordable, and Effective Medicines for Ukrainians (SAFEMed) to Management Sciences for Health (MSH) in September 2017.

SAFEMed applies health system-strengthening best practices to create evidence-based interventions and strengthen Ukraine's pharmaceutical system in line with the MOH's health care reform objectives. SAFEMed has three primary project objectives working in unison towards achieving sustainable healthcare system in Ukraine:

- 1) Strengthening governance within the pharmaceutical sector of Ukraine;
- 2) Optimizing the financing of the pharmaceutical sector; and
- 3) Increasing the availability and appropriate use of medicines in Ukraine.

Advancing Public Procurement Instruments and Operations, Centrally and Regionally is one of SAFEMed work streams, which involves providing comprehensive support to the MOH and SE "Medical Procurement of Ukraine" (MPU). MPU is well performing entity within the MOH of Ukraine with a strong history of integrity and good performance. Building off this positive history it is the desire of Ukraine MOH to expand the responsibilities and functions under MPU control in order to establish a full cycle national procurement and supply chain entity.

Since August 2022, MPU is in the process of absorption of another state enterprise – the state enterprise for the supply of medical institutions "Ukrmedpostach" of the Ministry of Health of Ukraine, which is in the process of reorganization. It is based on state property and belongs to the sphere of management of MOH. The enterprise was formed for the purpose of carrying out economic and commercial activities to achieve economic and social results with the aim of obtaining profit by providing services for the provision of health



care facilities and other enterprises and organizations, regardless of the forms of ownership, with equipment, inventory (non-food products), food products, medicines, medical products, medical equipment, motor vehicles, etc.

The property of Ukrmedpostach is a state property and is attached to it by the right of commercial ownership. According to the Charter of Ukrmedpostach, in the case of transfer of the enterprise to the sphere of management of another management body, the enterprise retains the right of economic transfer to the property assigned to it. In accordance with the procedure established by law, Ukrmedpostach ensures registration and state registration of property rights to objects, the rights to which are subject to state registration.

Current address of Ukrmedpostach: 02098, Kyiv, str. Bereznyakivska, building 29. The total area of the complex of buildings of Ukrmedpostach is 5,060 m2.

# Project goal

Due to the numerous reconstruction processes, which took place on Ukrmedpostach, SAFEMed is looking for a short-term comprehensive service provider for the registration of the ownership right of an object of immovable property for MOH and the right of the full economic authority for the SE "Ukrmedpostach".

# 2. Description of services

The Contractor is expected to propose a comprehensive approach to provision of the necessary support to Ukrmedpostach to solve existing real estate issue, which must include the following phases:

- 1) Entering the information about the State's ownership rights and the right of the full economic authority of the object (state registration) into the Unified Register of State-owned Objects.
- 2) Performing technical inventory of the object (including preparation of the technical passport, issuing technical passport).
- 3) Entering the data on the provided reconstruction of the object into the State Register of Construction Activities.
- 4) Solving the issue of address duplication for the mentioned real estate object with third parties.
- 5) Providing consulting services, drafting, and submitting the documents on behalf of MOH and Ukrmedpostach.

**Required involved bodies (including conducting all necessary contracts in the interest of the issue, as a turn-key project):** Bureau of Technical Inventory, construction participants, the State Property Fund of Ukraine, state registrar or notary.

## **Deliverables:**

Confirmed comprehensive implementation of the services to complete the described above Scope of Work shall be considered as the deliverable. Namely expected results of service provision are:

- 1) Necessary consulting services provided, documents drafted on behalf of MOH and Ukrmedpostach.
- 2) Technical passport on the full complex of Ukrmedpostach real estate is prepared, validated, and issued.
- 3) Legalization of the complex of buildings of Ukrmedpostach is done in compliance with the legislation of Ukraine, in particular problematic issues related to information on the duplication of data on the address of the real estate object with third parties is solved.



- Relevant data on Ukrmedpostach complex of buildings is entered into all necessary state registers.4) Registration of ownership rights of MOH and in the case of Ukrmedpostach the full economic authority of the object of immovable property is done.
- **Period of provision of services:** expected term of 3 months.

**Contract type:** it will be a fixed-price contract with the deliverable basis payment scheme in UAH without VAT after completion of each implementation stage.

### **3.** Qualification requirements

To participate in this tender process, the bidder must comply with the following requirements:

- Legal Ukrainian registration (company or private entrepreneur).
- Experience of providing consulting services in the sphere of legalization of different types of real estate reconstruction, including the most complicated ones, inter alia solving problematic issues no less than 5 years.
- Validity of the proposal for 90 calendar days.
- Acceptable payment terms (payment on delivery in UAH without VAT during 10 bank days after each implementation stage).

### 4. Terms of payment and requirements for VAT exemption

The SAFEMed project is entitled to tax benefits and is exempt from VAT on goods (works, services) purchased in the customs territory of Ukraine, so payment for services is made without VAT. Applicants who are VAT payers must be ready, in case of acceptance of the tender offer, to go through the procedure of exemption from value-added tax (see "Requirements for exemption from VAT" below).

Requirements for exemption from VAT	The Safe, Affordable and Effective Medicines for Ukrainians (Safe and Affordable Medicines) - SAFEMed project is an international technical assistance project implemented in Ukraine with the financial support of the United States Agency for International Development (USAID), Agreement No. AID-121-C-17-00004, following the Agreement between the Government of Ukraine and the Government of the United States of America on humanitarian and technical and economic cooperation of May 7, 1992 (hereinafter - the "Agreement"). The project purchases goods, works and services from the Tender Winner following the above Agreement and the Procedure for Attracting, Using and Monitoring International Technical Assistance, approved by the Resolution of the Cabinet of Ministers of Ukraine of February 15, 2002, N 153 (153-2002-π) "On creation of a unified system for attracting, using and monitoring international technical assistance". The cost of such goods, works and services is exempt from value-added tax. Procurement of goods, works and services specified in the procurement plan.

#### 6. Content of the proposal

Proposals should be submitted by two separate files with the following information:

1. Technical Proposal.

2. Cost Proposal.

Proposals should be submitted in English or Ukrainian. Registration documentation does not require translation and should be submitted in the origin language.

#### 7.1. Technical Proposal

## **7.1.1. Required copies of documents under the qualification requirements:**

- Registration documents of a legal entity.
- Compliance with qualification requirements (Appendix #1).

#### 7.1.2. Full contact information of the offeror:

- Legal name, physical and legal addresses.
- VAT payer registration number, EDRPOU identification code.
- Contact person.

#### 7.1.3. Offeror's capacity and experience:

- Information on successful implementation of similar projects.
- Offeror's portfolio with the following description:
  - experience of dealing with technical inventory of the object, including preparation of the technical passport, issuing technical passport;
  - ✓ experience of working with state owned entities in Ukraine, problematic objects;
  - experience in providing complex support of entering real estate data to the Unified Register of State-owned Objects, the State Register of Construction Activities;
  - ✓ experience of working with Bureau of Technical Inventory, construction participants, the State Property Fund of Ukraine, state registrar or notary.



- CV of the proposed team for project implementation.
- Project implementation plan with proposed phases and expected timeframes.
- Feedbacks from current/former clients (at least 3 contacts for references or reference letters from companies, institutions, etc.).

The following shall be significant additional advantage:

- work experience in relevant governmental bodies regarding real estate.

#### 7.2. Cost Proposal

Information on the total cost of services following the scope of work:

- Overall summary budget.
- Budget with detailed breakdown into stages of the project implementation including all expenses and other related costs that may arise during the performance of the contract.

Since the complex of service provision includes the need to conclude additional agreements and make official payments, such a breakdown should be clearly shown in the offer. Cost proposal will lay in the background of the contract. Please note, if any of the deliverable is not reached, there will be no payment according to the breakdown of the cost proposal (contract).

#### Prices must be offered in UAH without VAT.
