**Project Name:** Contribution to the Resilience of conflict-affected population via the Livelihood Assistance in UA

**Project Description:**

Mercy Corps in partnership with Swiss Development Cooperation (SDC) has been implementing the “Ukraine Economic Resilience Programme” (ERP), that is aimed at market recovery through support to micro, small and medium enterprises, households, and small to medium farming enterprises.

The programme aims to support internally displaced persons (IDPs) and conflict-affected population to have stable livelihoods and reduced reliance on cash and in-kind support. The programme is working with IDPs, conflict-affected population, small and medium-sized enterprises (SME), subsistence farmers, small and medium farming enterprises, and vocational education training institutions as well as Diia.Business consulting centres. The programme is implemented in Dnipro, Kyiv, Poltava, Chernihiv, Sumy, Lviv, Ivano-Frankivsk, and Ternopil oblasts.

Mercy Corps works in partnership with Helvetas Swiss Intercooperation (Helvetas), Right to Protection (R2P), and Joint Emergency Response for Ukraine (led by Welthungerhilfe) through a network of local partners and has strong linkages with and access to marginalised, hard-to-reach, and underserved communities.
