- 3. Sealed tenders must be submitted by **14.08.2024**, **5pm local time** at CESVI Country Office (Bohdana Khmelnytskoho street, No 42, office 17, Kyiv, Ukraine) and should be marked as **"Not to be opened before 15.08.2024 12.00 local time"**.
- 4. Electronic bidding is **NOT ALLOWED**, failure to take heed will automatically get a disqualification.
- 5. Tenders opening session will be held in Bohdana Khmelnytskoho street, No 42, office 17, Kyiv, Ukraine on **15.08.2024 at 12.00 local time**, in the presence of bidder's representatives (only one representative from each bidder), who wish to witness the tender opening.
