EXPERT SERVICES ON DEVELOPMENT OF A GENDER BASE ANALYSIS STUDY RELATED TO ODESA REGION HEALTHCARE FACILITIES WITHIN THE IMPLEMENTATION OF THE REHAB PROJECT

I. CONTEXT

Expertise France is the French public international cooperation agency. It designs and implements projects which aim to contribute to the balanced development of partner countries, in line with the Sustainable Development Goals (SDGs) of the 2030 Agenda and the priorities of France's external action. Expertise France's mission is to meet the demand of partner countries seeking to enhance the quality of their public policies in order to address the environmental, social, economic and security challenges they are facing. The agency achieves this goal by implementing projects in the main areas of public action:

- Democratic, economic and financial governance;
- Stability, international security and peace Stability, international security and peace
- Sustainable development, climate and agriculture
- Health and human development

The REHAB project – Recovery, rEform, and reHABilitation of the Ukrainian Health System is a project funded by French Development Bank (AFD), in the amount of €5 million over 24 months.

General objective: Supporting Ukraine in financing, maintaining and strengthening its healthcare system to address the consequences of the conflict on the physical and mental health of Ukrainians.

- OS1: Strengthen the provision of mental health and physical rehabilitation services within the healthcare pyramid by implementing reforms, providing training, supplying equipment, and rehabilitating healthcare facilities.
- OS2: Leverage gender-sensitive feasibility studies to improve access to health financing, supporting the long-term recovery of municipalities and regions in Ukraine.

IV. PROCUREMENT PROCEDURE

The present procurement procedure is subject to the French Code of public procurement in its latest version in force as enacted by Order No. 2018-1074 issued on 26 November 2018 and its Implementation Decree No. 2018-1075 issued on 3 December 2018.

Expertise France proceeds with the "adapted procedure" by virtue of applying articles L. 2123-1 and R. 2123-1 au R. 2123-7 of the above mentioned Code.

VI. PRESENTATION OF TENDERS

The application and tender documents as well as all correspondence and documents relating to this consultation must be written in English.

In support of their offer, candidates must submit a file consisting of the following documents:

- A proof of a legal identity form;
- Bank statement about open accounts in English;
- Certificate of absence of tax debt for company;
- The expression of interest form and his appendices, the declaration of honour on exclusion criteria and absence of conflict of interest template and the identification sheet of a third party;
- Suggested implementation timeframe;
- CVs of the personnel to be involved in the activities and the respective certificates and their roles during the assignment;
- Proof of previous Experience of the service provider in similar areas of intervention (should state the thematic, size of project, region);
- Filled and signed financial proposal (in UAH and EUR) according to the Financial Proposal Template. The vendor should provide the detailed calculation in free from in addition to the completed Financial Proposal Template.
- For any contract whose execution implies the movement of its personnel (or its subcontractor) in an orange or red zone (in accordance with the regional vigilance maps made available by the Ministry of Europe and Foreign Affairs (https://www.diplomatie.gouv.fr/fr/conseils-aux-voyageurs/) the safety evaluation questionnaire completed.

The documents requested above are mandatory. If they are missing, the tender submitted will not be compliant and will therefore be rejected.

The period of validity of the tenders submitted is fixed at 90 calendar days from the deadline for submission of tenders.

VII. TRANSMISSION MODALITY OF TENDERS

All the required documents must be submitted before the deadline indicated in article III. <u>PROCEDURE'S SCHEDULE</u>, by electronic means only, to the address <u>tender-ukraine@expertisefrance.fr</u> (Attention! The message size should not exceed 7 MB, otherwise we will not be able to receive your message. If you are going to send a large message, please send it in parts or place the files on a storage (e.g. Google drive) and share the link.)

Submission by electronic means is mandatory. Any other form of submission will be rejected.

VIII. SELECTION PROCEDURE

Expertise France will first check the eligibility of the applications and their ability to provide the service. Finally, it will evaluate the offers according to the following criteria:

- Criterion 1: Price (40 points)
- Criterion 2: Technical value (50 points):
 - Experience of the relevant expert or team of experts and their qualifications 30 points
 - Quality and consistency of the methodology implemented (Methodology of intervention, Consistency with the terms of reference, Syntax/presentation, Experience of the organization in similar areas of intervention (thematic, size of project, region) 20 points

Criterion 3: Suggested timeframes – 10 points

Expertise France may, if it deems necessary, open negotiations with all or some of the tenderers and will conclude the contract with the entity that submitted the best-rated tender in the light of these criteria.



IX. SELECTION PROCEDURE
