### **QUESTIONS & ANSWERS RFP REQ-KYI-25-0042**

### Q. 1: Для формування пропозиції на ліцензії програмних продуктів потрібна інформація, хто (яка юрособа) буде майбутнім ліцензіатом.

А.: Ліцензіатом буде один із закладів вищої освіти України.

### Q. 2: Щодо CISCO: позиції 1-2 – чи потрібні контракти Smart Net?

А.: Потрібен той контракт, який забезпечує оновлення ПЗ. Швидка заміна обладнання, як для бізнесу, не потрібна.

### Q. 3: Eaton 3kVA – яка конфігурація потрібна, «башта» чи для встановлення у стійку?

А.: Необхідна конфігурація для встановлення у стійку (rack-mounted), щоб забезпечити інтеграцію із серверною інфраструктурою.

### Q. 4: Server Dell PowerEdge R250, Intel Xeon, 32 GB RAM, 2 TB HDD: is there more precise requirements for the processor?

A.: Regarding the processor for the Dell PowerEdge R250, we offer the following configuration: Processor: Intel Xeon E-2336 (6 cores / 12 threads, 3.4 GHz base, up to 5.0 GHz turbo, 12 MB cache, 65W TDP)

The model is compatible with the R250, has high reliability, and is recommended for log servers, SIEM systems, and monitoring tasks.

#### Q. 5: Lenovo ThinkSystem SR630 server. Please specify requirements for:

- RAM volume
- disk space and types of disks, what network interfaces are needed, one or two power supplies
- network interfaces
- quantity of power supplies (1 or 2)

A.: Processors: 2 × Intel Xeon Scalable (Silver/Gold, Gen 2 or 3, up to 28 cores per processor)

RAM: Supports up to 3 TB DDR4, 24 DIMM slots

Storage: Up to 10 SFF drives (SSD/HDD/NVMe), with the ability to connect up to 2 TB drives for large data volumes

RAID controller: ThinkSystem RAID 930-8i (with support for RAID 0, 1, 10, 5)

Management system: Lenovo XClarity Controller (remote management, status monitoring, firmware updates)

Power supplies:  $2 \times 750$ W (Redundant, to ensure uninterrupted operation)

Cooling: Supports active cooling with automatic fan speed adjustment

Virtualization: Supports VMware, Hyper-V, Proxmox for running virtual machines

Interfaces:  $2 \times 10 \text{GbE}$  for high-speed server-to-server connectivity, supports 1 GbE and 10 GbE adapters

Expansion: Up to  $2 \times PCIe$  Gen 3 slots for additional expansion cards (e.g. for cloud or compute tasks).

# Q. 6: Taking in account that "Prices must include all costs, logistics, and final delivery to the recipients" and that the recipients are located in 4 different cities (Chernihiv, Lviv, Zhytomyr, and Sumy) which are different in the sense of distance and logistics costs, could you clarify which product and to which location (city only, no address) should be delivered?

A.: Due to security reasons, CCI cannot disclose such information at this stage of the tender. However, understanding the constraints and peculiarities of the logistics cost composition, we suggest that your company utilize a unified approach and convene the necessary calculations based on the overall weight of the required items and the 4 geographic locations specified in the RFP.

A.: Please be advised that CCI will only accept full applications for this solicitation. Hence, only the Pricelists with 100% of the required items should be submitted.

## Q. 8: Чи допускаються до розгляду аналоги обладнання, це особливо стосується ноутбуків.

A.: Yes, similar equipment may be considered as replacements, including laptops, but only under specific conditions. Replacements are allowed if the originally requested items are unavailable in stock and the proposed alternatives have comparable technical characteristics. Any substitutions must be approved in advance by the recipient's higher education institution. Please coordinate with the Activity team to initiate the approval process in such cases.
