LOT 4. HOUSEHOLD GOODS(Trash bin, Dishwash liquid, Paper towels, Cloths, Glass cleaner, Paper cup, Rapid COVID-19 tests, etc)

LOT 5. FURNITURE(Office desk, Table, Cabinet, Cloth Hanger, Wall shelf, Metal Storage Rack, Office chair, Coffee Machine , etc)

- Shortlisted companies will be invited to participate in the subsequent formal tender process.
