FOR CONDUCTING A TECHNICAL INSPECTION AND DAMAGE ASSESSMENT OF BUILDINGS NO.3 AND NO.4 OF THE SHUPYK NATIONAL HEALTHCARE UNIVERSITY OF UKRAINE (NUOZ)

I. CONTEXT

Expertise France is the French public international cooperation agency. It designs and implements projects which aim to contribute to the balanced development of partner countries, in line with the Sustainable Development Goals (SDGs) of the 2030 Agenda and the priorities of France's external action. Expertise France's mission is to meet the demand of partner countries seeking to enhance the quality of their public policies in order to address the environmental, social, economic and security challenges they are facing. As part of France's strategy for reconstruction and aid in Ukraine focusing on the health sector The French Ministry of Europe and Foreign Affairs (MEAE)'s Crisis Center (CDCS) has financed €16 million over 24 months to the **APPUI** Health Project from 2024 to 2025. The project, implemented in partnership with Ministry of Health of Ukraine and other key stakeholders aims to improve Ukrainian populations' access to essential healthcare services in times of crisis. The project focuses on enhancing hospital cooperation between France and Ukraine, mobilizing French expertise, reconstructing and modernizing healthcare infrastructure and donating medical equipment at the request of Ministry of Health of Ukraine.

IV. PROCUREMENT PROCEDURE

The present procurement procedure is subject to the French Code of public procurement in its latest version in force as enacted by Order No. 2018-1074 issued on 26 November 2018 and its Implementation Decree No. 2018-1075 issued on 3 December 2018.

Expertise France proceeds with the “adapted procedure” by virtue of applying articles L. 2123-1 and R. 2123-1 au R. 2123-7 of the above mentioned Code.

V. CONTENT OF THE TENDER DOSSIER

The tender dossier is composed by the following documents :

VI. PRESENTATION OF TENDERS

The application and tender documents as well as all correspondence and documents relating to this consultation must be written in English.

In support of their offer, candidates must submit a file consisting of the following documents:

- A proof of a legal identity form;
- Bank statement about open accounts in English;

- Certificate of absence of tax debt for company;
- Filled and signed Declaration of honour on exclusion criteria and absence of conflict of interest template and the identification sheet of a third party;
- License or authorization permitting the company to conduct technical inspections and prepare construction technical reports in Ukraine (mandatory).
- CV(s) of proposed expert(s).
- Copies of diplomas, certifications, or professional licenses of the staff involved.
- A technical offer comprising:
 - o Detailed methodology for carrying out the inspection and reporting.
 - o Work plan, including timeline and distribution of tasks.
- Financial proposal (in UAH) using the FINANCIAL PROPOSAL template.
- List of similar assignments completed in the past 5 years, ideally relating to: War-damaged or emergency infrastructure assessment, Government or donor-funded work, DBN-compliant technical reporting.
- Statement confirming responsibility for logistics, transport and safety during field visits;
- For any contract whose execution implies the movement of its personnel (or its subcontractor) in an orange or red zone (in accordance with the regional vigilance maps made available by the Ministry of Europe and Foreign Affairs (<https://www.diplomatie.gouv.fr/fr/conseils-aux-voyageurs/>) the safety evaluation questionnaire completed.

The documents requested above are mandatory. If they are missing, the tender submitted will not be compliant and will therefore be rejected.

The period of validity of the tenders submitted is fixed at 90 calendar days from the deadline for submission of tenders.

VII. TRANSMISSION MODALITY OF TENDERS

All the required documents must be submitted before the deadline indicated in article III. PROCEDURE'S SCHEDULE, by electronic means only, to the address tender-ukraine@expertisefrance.fr

Attention! The message size should not exceed 7 MB, otherwise we will not be able to receive your message. If you are going to send a large message, please send it in parts or place the files on a storage (e.g. Google drive) and share the link.

Submission by electronic means is mandatory. Any other form of submission will be rejected.

VIII. SELECTION PROCEDURE

Expertise France will first check the eligibility of the applications and their ability to provide the service. Finally, it will evaluate the offers for each bid according to the following criteria:

- Criterion 1: Price (45%)
- Criterion 2: CV pertinence (20%)
- Criterion 3: Methodology (20%)
- Criterion 4: Timeline (15%)

REQUEST FOR PROPOSAL

Expertise France may, if it deems necessary, open negotiations with all or some of the tenderers and will conclude the contract with the entity that submitted the best-rated tender in the light of these criteria.
